## **Biographical Sketch**

---

Dr. Jeffrey Kai-Chieh Chia is a Professor in logistics and supply chain management at the Business School, Soochow University, Taiwan. Professor Chia is also the Advisor to the Minister of Economic Affairs, Taiwan, ROC.

Professor Chia has served as an advisor on logistics and supply chain operations to many leading companies in Taiwan, among them China Airlines, YangMing Marine Transport Corp., and China Steel Corporation (CSC). He serves on the boards of directors of China Steel Chemical Corporation, Taiyen Biotech Co., Ltd., Taiwan SECOM Company Ltd., and Taiwan Aerospace Corp. (TAC) and on several advisory boards of emerging companies.

Professor Chia is also a counselor to government. He plays an active role in Taiwan economic and transportation policy with the Executive Branch and international

organizations. Dr. Chia is the advisor to the Minister of Economic Affairs. He has also served as the board member of Aviation Safety Council (ASC) of Taiwan, and the Science and Technology Advisor to the Minister of Transportation and Communications. Most recently, he led the project which explored new business model and new development strategy about the free trade zone of Taoyuan airport city in Taiwan.

Professor Chia has served as an advisor to numerous government and non-government organizations, such as APEC transportation working group, the Taiwan Roundtable of the Council of Supply Chain Management-Professional (CSCMP), the Global Logistics Council of Taiwan, and the International Society of Logistics (SOLE)-Taiwan District, among others.

Professor Chia received his Ph.D. in Logistics and Supply Chain Management from Chiao Tung University in 2002. Prior to entering academe, Dr. Chia served as the Special Assistant to Vice Minister of Transport and worked as the Senior Researcher in the Institute of Transportation, MOTC, Taiwan from 1991-2003.

Dr. Chia's research interests are in the areas of corporate governance, global logistics planning, supply chain management, airlines business and management, and transportation economics. He has published in a number of academic journals including *Transport Reviews*, *European Journal of Operational Research*, and *Transportation Planning Journal* and has co-authored five books, *Global Logistics management*, *Air Transportation Management*, *Comparative Research on Logistics Policy between Mainland China and Taiwan*, *Comparative Research on Port Development between Mainland China and Taiwan* and *Air Transportation*.
